### Deposit and Refund Policy.

Kennolyn has limited enrollment and can only accept a certain number of campers in each age group. Every application must be accompanied by the appropriate deposit: Resident, and Leadership Camps: \$500 per camper per session; Day Camp: \$200 per camper per session; Family Camp: \$500 per family. Tuition for all sessions must be paid in full by May 31. Applications accepted after May 31 must be accompanied by full payment.

### All cancellations must be submitted in writing.

#### Cancellation policy and fees for Resident, Leadership, and Family Camps:

Cancellations received on or before April 1: cancellation fee = \$250

Cancellations received after April 1, but on or before June 1: cancellation fee=\$500

Cancellations received after June 1 shall remain liable for the full amount of tuition for the entire session reserved

#### Cancellation policy and fees for Day Camp:

The deposit is nonrefundable, regardless of date or circumstances of cancellation

In all cases, cancellations received after June 1 shall remain liable for the full amount of tuition for the entire session reserved

Changing sessions after enrollment in any camp program. If you reduce the length or number of sessions after initial enrollment, you will incur a \$100 change fee as long as you remain enrolled in one complete session. This charge is incurred each time a session reduction occurs. Switching sessions of equal length, or increasing the length or number of sessions is offered at no charge but is subject to space availability.

### You will receive no refund if:

- 1) Your camper is dismissed from camp. We reserve the right to ensure the safety and well being of all campers and to dismiss a camper, without refund, for misconduct or unsociable behavior as determined by the Directors.
- 2) You choose to withdraw a camper for any reason before he / she has completed the entire session they were enrolled for.

Summer camp is a wonderful experience for boys and girls and teaches them a great deal about themselves and the world around them. Part of the magic of camp is that the activities take place in the out of doors and campers are invited to explore new challenges. Obviously, with these challenges comes risk. Our purpose in this disclosure is not to worry you, but to point out that there are risks connected with the fun, excitement and adventure of a camp experience.

**Assumption of Risk.** You, as parent and/ or guardian of your Child(ren) are aware of the inherent risks of injury, death, and property damage involved in camp activities including but not limited to ropes course, surfing, climbing, swimming, diving, backpacking, mountain biking, horseback riding, whitewater rafting, kayaking, circus, trapeze, etc. including without limitation risks due to drowning, near drowning, falls, horse related injuries, etc. You as parent and/ or guardian of your Child(ren) are aware of the risks of injury, death, and property damage that may result from, among other causes, the act of active and passive negligence of Kennolyn Camps, Inc. and its sister corporations, all officers, directors, shareholders, employees, agents, representatives, successors, assigns, and heirs (collectively, "related parties"), including without limitation the risk of negligent instruction or supervision. You as parent and/ or guardian have voluntarily allowed your Child(ren) to engage in activities including but not limited to ropes course, surfing, climbing, swimming, diving, backpacking, mountain biking, horseback riding, whitewater rafting, kayaking, circus, trapeze, etc., with knowledge of the risks of injury, death, property damage, and other risks, and assume any and all known and unknown risks of injury, death, & property damage that may result from camp activities including but not limited to ropes course, surfing, climbing, swimming, diving, backpacking, mountain biking, horseback riding, whitewater rafting, kayaking, trapeze, etc.

**Release of liability.** You as parent and/ or guardian of the Child(ren) hereby release the related parties from all liability to you as parent or guardian, and or Child(ren), principals, employees, agents, representatives, guardians, successors, assigns, heirs, and next of kin for all liability, claims, damage, or demands from personal injury, death, or property damage, arising from or related to this agreement or to camp activities including but not limited to ropes course, surfing, climbing, swimming, diving, backpacking, mountain biking, horseback riding, whitewater rafting, kayaking, circus, trapeze, etc., whether the injury, death or property damage occurs on or off the premises. This release includes, without limitation, any personal injury, death, or property damage caused by the active or passive negligence of any of the released parties. You as the parent and/ or guardian of the Child(ren) bear sole responsibility for any loss.

**Hold Harmless.** You as parent and/ or guardian shall indemnify, defend, and hold harmless Kennolyn Camps, Inc. and its sister corporations, all officers, directors, shareholders, employees, agents, representatives, successors, assigns, and heirs (collectively, "indemnitee"), against all liability, demands, claims, costs, losses, damages, recoveries, settlements, and expenses (including interest, penalties, attorney's fees, expert witness fees, costs, and expenses) incurred by indemnitee ("losses"), known or unknown, contingent or otherwise, directly or indirectly arising from or related to your Child(ren)'s participation in Kennolyn Camps, Inc. activities.

**Choice of Law; Jurisdiction.** All questions with respect to the construction of this agreement and the rights and liabilities of the parties shall be determined in accordance with the applicable provisions of the laws of the state of California.

**Knowing and voluntary execution.** You as parent and/ or guardian of the Child(ren) acknowledges that you have carefully read this agreement, understand its contents, understand that this agreement includes an assumption of the risk of the released parties negligence and a release of their liability. You as parent and/ or guardian of the Child(ren) acknowledge that Kennolyn Camps, Inc. is materially relying on this waiver and is allowing your Child(ren) to engage in camp activities including but not limited to ropes course, surfing, climbing, swimming, diving, backpacking, mountain biking, horseback riding, whitewater rafting, kayaking, circus, trapeze, etc.

**Kennolyn** cannot accept responsibility for any personal item lost or damaged by fire, theft, or in the laundry.

**Kennolyn** may use any pictures or videos taken of campers and families during camp time. This includes digital images, which may be posted on our web site. We may transfer the rights to use images of campers to third parties.

It is essential that any pertinent information, including any social, emotional or physical problems that might limit a camper's active participation in camp activities be discussed with the directors prior to acceptance and attendance at camp. We want this to be a successful experience for the camper and the camp. This confidential information may be sent by letter, telephone, fax, or personal visit.

An optional program at Kennolyn's Resident Camp is the 3 day backpacking trip to Big Basin State Park. I hereby give permission for my child or ward to participate in the backpacking trip under the supervision of Kennolyn staff. I understand that this trip will include camping and hiking on property within Big Basin State Park operated by California State Parks.
